

WEB SITE COOKIES POLICY FOR WWW.SOGRAPE.COM

WHAT ARE COOKIES?

A Cookie is a small file stored on the visitor's device in order to persistently maintain some information that allows identifying the type of device, as well as other relevant information to make it available correctly and to adapt all the components of the website, including the ability to do login to client areas.

DOES WWW.SOGRAPE.COM WEBSITE USE COOKIES?

Yes, to improve the experience of using the website www.sogrape.com and to offer a personalized service. Cookies are used to maintain visitor information, allowing you to determine the language you prefer, assist in completing forms and collect performance indicators, origin and time of access to the website.

WHAT IS THE PRIVACY POLICY FOR THE WEB SITE WWW.SOGRAPE.COM?

Data collected and stored in Cookies will not be made available by SOGRAPE to third parties and will only be used for marketing campaigns with the authorization of the visitor. Navigation on the website is monitored for statistical purposes only.

SHOULD I ACCEPT USE OF COOKIES?

In compliance with Law 41/2004, of 18 August and Law 46/2012 of 29 August, the website www.sogrape.com may only use the use of Cookies with the prior and express consent of the visitor. SOGRAPE undertakes to use the Cookies store only for the purposes referred to in the preceding paragraphs.

It is important to note that the use of Cookies is essential for the correct functioning of the website in its entirety, so its acceptance is recommended.

Most browsers allow you to control the Cookies stored on your device, as well as their immediate deletion if you want to stop allowing local storage of Cookies. You can change your browser settings to avoid or notify each time a cookie is set.

WHAT COOKIES ARE USED ON THE WWW.SOGRAPE.COM WEB SITE?

The following table provides an explanation of the Cookies used on the website www.sogrape.com and its purpose.

Cookie	Name	Duration	Reason
Google Analytics	_ga	2 years	Used to distinguish users.
Google Analytics	_gid	2 years	Used to distinguish users.
Google Analytics	_gat	1 minute	Used to control request rate
Google Analytics	_utm(a,t,b,c,z)	Until end of session Or 2 years limit	Used to distinguish users and sessions. The cookie is created when the JavaScript library is run and when there are no cookies. The cookie is updated each time the data is sent to Google Analytics.
Site	laravel_session ,ageCheck and cookies	Until end of session Or 2 years limit	Cookies used to store a reference to the user session and to control whether the user has already seen the cookie policy warning bar
Google Maps	XSRF-TOKEN	1 hour	This cookie is used to connect to Google maps to show the global map.
